

**ORDINANCE ADDRESSING FLOODPLAIN MANAGEMENT PROVISIONS  
OF THE STATE CONSTRUCTION CODE**

**The Charter Township of AuSable, Iosco County Michigan (All Jurisdictions)**  
Ordinance Number 108

An ordinance to designate an enforcing agency to discharge the responsibility of the Charter Township of AuSable located in Iosco County, and to designate regulated flood hazard areas under the provisions of the State Construction Code Act, Act No. 230 of the Public Acts of 1972, as amended.

The Charter Township of AuSable ordains:

**Section 1. AGENCY DESIGNATION.** Pursuant to the provisions of the state construction code, in accordance with Section 8b(6) of Act 230, of the Public Acts of 1972, as amended, the Building Official of the County of Iosco as the enforcing agency to discharge the responsibility of the Charter Township of AuSable under Act 230, of the Public Acts of 1972, as amended, State of Michigan. The County of Iosco assumes responsibility for the administration and enforcement of said Act through out the corporate limits of the community adopting this ordinance.

**Section 2. CODE APPENDIX ENFORCED.** Pursuant to the provisions of the state construction code, in accordance with Section 8b(6) of Act 230, of the Public Acts of 1972, as amended, Appendix G of the Michigan Building Code shall be enforced by the enforcing agency within the County of Iosco.

**Section 3. DESIGNATION OF REGULATED FLOOD PRONE HAZARD AREAS.**  
The Federal Emergency Management Agency (FEMA) Flood Insurance Study (FIS) entitled Iosco County, Michigan (All Jurisdictions), and dated January 6, 2012 and the Flood Insurance Rate Map(s) (FIRMS) panel number(s) of 26069C; 0270E, 0286E, 0287E, 0288E, 0289E,

0409E, 0410E, and 0430E dated 1/6/12 are adopted by reference for the purposes of administration of the Michigan Construction Code, and declared to be a part of Section 1612.3 of the Michigan Building Code, and to provide the content of the “Flood Hazards” section of Table R301.2(1) of the Michigan Residential Code.

**Section 4. REPEALS.** All ordinances inconsistent with the provisions of this ordinance are hereby repealed.

**Section 5. PUBLICATION.** This ordinance shall be effective after legal publication and in accordance with the provisions of the Act governing same.
