ORDINANCE NO. 27

AN ORDINANCE PROHIBITING DISORDERLY CONDUCT OF PERSONS, PUBLIC INTOXICATION, PROFANITY, FIGHTING, UNLAWFUL ASSEMBLANCES FOR UNLAWFUL PURPOSE, DEFACING OF PUBLIC OR PRIVATE PROPERTY; TO SPECIFICALLY DEFINE THE CONDUCT HEREIN PROHIBITED; AND TO PROVIDE PENALTIES FOR THE VIOLATION THEREOF.

Effective August 10, 1977

THE TOWNSHIP OF AUSABLE ORDAINS:

- **Section 1. DISORDERLY CONDUCT**. It shall be unlawful for any person to be guilty of disorderly conduct or of any conduct tending toward a breach of the peace. The causing or making of any unnecessary loud noise or shouting or yelling shall be considered disorderly conduct.
- **Section 2. PUBLIC INTOXICATION**. It shall be unlawful for any person to be in an intoxicated condition in or on any street, alley or other public place in the Township.
- **Section 3. FIGHTING**. It shall be unlawful for any person to knowingly start a fight, or to fight, or to commit any assault or battery in any public place in the Township.
- **Section 4. ASSEMBLAGES FOR UNLAWFUL PURPOSE**. It shall be unlawful to collect, gather, or to be a member of any disorderly crowd, or any crowd gathered for any unlawful purpose.
- **Section 5. DEFACING PUBLIC OR PRIVATE PROPERTY.** No person shall mar, injure, destroy or deface, or aid in the injuring, destroying or defacing in this Township, any public or private property, or cause to be posted or stuck, any handbill for placard upon any public or private building, or upon any fence or other property within the township without the permission from the owner or occupant first obtained; or mar, injure, destroy or deface or cause to be marred, injured, destroyed or defaced any bridge, fence, tree, street sign, awning, lamp post, electric light post, or apparatus or any other property, not belonging to the person so offending whether public or private.
- **Section 6. SEVERABILITY.** If any section, provision, phrase or word of this Ordinance, shall be held void, ineffectual or unconstitutional by a Court a competent jurisdiction, then such finding shall no defect the validity of the remaining sections, provisions, phrases or words thereof.
- **Section 7. PENALTIES.** Violation of any of the provisions of this Ordinance shall be punishable by a fine of not more than \$100.00 and the cost of prosecution of by imprisonment in the County jail for a period not to exceed ninety (90) days, or both, as may be determined by the Court.

Section 8. EFFECTIVE DATE. This ordinance shall become effective upon publication in accordance with the Statute, in such case made and provided.
