

ORDINANCE 47

AN ORDINANCE TO PROVIDE FOR WATER CONNECTION CHARGES FOR THE FOREST ROAD WATER PROJECT; SPECIAL ASSESSMENT DISTRICT PAYMENTS ACCOUNTING FOR SPECIAL ASSESSMENT DISTRICT NO. 3 (FOREST ROAD WATER PROJECT).

Effective December 5, 1988

THE CHARTER TOWNSHIP OF AUSABLE ORDAINS:

SECTION ONE: - CONNECTION CHARGES:

1. Connection charges to the municipal water system for the Charter Township of AuSable for all properties served by the Forest Road Water Project generally included within Special Assessment District No. 3 shall be as follows:

A. The connection charge for those individuals who connect to the municipal water system within 60 days after notification by the Township Water Department that municipal water is available and who had a water tap installed at the time of construction of the waterline shall be \$250.00 plus meter, reader and yoke.

B. The connection charge for those individuals who do not connect a water tap installed at the time of the Road Water Project shall be \$500.00 plus for municipal water service within 60 days but who had construction of the Forest meter, reader and yoke.

C. The connection charge for those individuals located within the Special Assessment District No. 3 (Forest Road Water Project) who do not connect within 60 days after notification by the Township Water Department and who do not request a tap be installed at the property line at the time of the construction of the water system will be charged time and material necessary to make the connection at a subsequent date.

D. The connection charge for those properties not in Special Assessment District No. 3 but who request a connection to the municipal water system and that connection would be off of the Forest Road Water Project, shall be that sum that the particular parcel of land would have had to pay had it been included within the Special Assessment District as a special assessment plus time and material to make the connection to the municipal water system.

2. All connection charges shall be paid in full prior to a meter being installed and/or municipal water being furnished to any customer.

3. All payments made pursuant to Special Assessment District No. 3 and connection charges for the Forest Road Water Project paid to the Township shall be deposited by the Township Treasurer in the AuSable Township Water Bond Interest and Redemption Fund. The same to be applied on the Township Municipal Water Bonds as they become due.

SECTION TWO: - All ordinances and parts of ordinances in conflict with this Ordinance are hereby repealed.
